By opting into our SMS program, you agree to receive SMS messages from Lincoln County Power District No. 1, in accordance with these Terms and The Campaign Registry (TCR) compliance standards.

Consent and Opt-In Requirements

- By opting in, you provide express consent to receive SMS messages from us regarding your account services.
- Opting into the SMS program is voluntary and separate from any other service we provide.
- To opt-in, text "**PowerHungry**" to 775-728-8200 or sign up via our website at www.LCPD1.com
 - **Opt-In Message:** Thank you for opting into **LCPD1** texting. Message frequency varies. Message & data rates may apply. Reply STOP to unsubscribe. Text HELP or call 775-728-8200 for more info.

Message Frequency and Types

- Message Frequency varies.
- Message Types: Messages may include service alerts and account notifications.
- Message and data rates may apply according to your mobile carrier's standard rates.

Opt-Out Instructions

- You may opt out of the SMS program at any time by texting "STOP" to 775-728-8200.
- Once you send the "STOP" request, you will receive one final confirmation message confirming that you have been unsubscribed. No further messages will be sent unless you opt back in.
